## Boost your chances of publication by following journals' instructions to authors

One of the easiest ways to improve your chances of getting your article published is to ensure that the manuscript meets all the requirements stated in your target journal's author instructions. The author instructions, which are found on the journal website, specify how manuscripts are to be formatted and organized and what information needs to be included. Following these instructions is important for many reasons.

- Following instructions demonstrates to editors and reviewers that you are careful with details. This will give editors and reviewers the impression that you have been equally careful in the performance of your research and give you an advantage over other authors who have not been as meticulous.
- Following instructions allows editors and reviewers to focus on the scientific merit of your work rather than its form. At best, papers that do not conform to journal requirements are distracting. At worst, they may irritate editors and reviewers and even cause them to reject a paper outright.
- Following instructions can speed up the review and publication process. If your paper has been carefully prepared, the journal can send it out for review without delay. In contrast, a paper that does not meet the journal's specifications—such as those for file format and inclusion of copyright transfer agreements and patient consent documentation—may be returned unread.

- Following instructions shows editors and reviewers that you prepared the manuscript with their journal in mind. A paper formatted incorrectly may give the impression that you have previously submitted the paper to another journal.

Be especially careful to note journal specifications for page or word counts, as authors often overlook these requirements and may have their papers returned to them as a result. If you [submit your manuscript to the Research Medical Library](#) for editing, your editor will let you know what changes you need to make to meet the requirements of your target journal.

## EndNote, Mendeley, Zotero: which citation management software is best?

A good citation management tool is essential for writing. It helps you:

- Store and organize citations and articles
- Share citations with collaborators
- Insert references and bibliographies into documents
- Automatically format references in the style you need

Dozens of different citations management tools are available, but each has different capabilities and price structures. EndNote, Mendeley, and Zotero are three of the best options. How do you know which is right for you? We'll review their pros and cons to help you decide.

## EndNote

EndNote is a desktop tool that can handle very large numbers of citations and organize them into groups. It offers the most journal styles to create references and bibliographies in the format you need. An online version is also available with fewer capabilities.

## **PROS**

- EndNote is expensive, but MD Anderson provides:
  - A free desktop version on MD Anderson-issued computers
  - A free web-based version on any computer
  - A [significant discount](#) for EndNote on a personal computer
- With EndNote you can:
  - Easily export articles from PubMed and other databases
  - Import multiple article PDFs with one click
  - Highlight and add searchable notes to PDFs
  - Store as many PDFs as you need. There's no limit except for your computer's capacity.
  - Choose from 100 pre-installed journal styles and an additional [6,000 downloadable styles](#)
  - Change from one journal style to another in Word with the click of a button
  - Customize journal styles or create your own
- The Research Medical Library provides [support for EndNote](#) with:
  - Online and face-to-face classes on basic and advanced EndNote features
  - Instant answers to your questions via [chat, text, or email](#)
  - An online [help guide](#) answering the most common questions

## **CONS**

- Not as easy to learn as other products
- MD Anderson's desk-top version can't be downloaded to your personal computer
- The web-based version has limited capabilities
- Using both the desk-top version and the web version simultaneously may be problematic
- Stores PDFs locally, not in the cloud
- If you leave MD Anderson, your new institution may not provide it
- Can't download webpage snapshots or create citation information about them
- Difficult to share with collaborators
- No mobile app

## **Mendeley**

Mendeley is an online tool that makes it very easy to download, organize, and create citation information simply by downloading PDFs. For an example of a Mendeley collection, see the Research Medical Library's public collection of [articles on COVID-19](#).

## **PROS**

- Free basic version with 2 GB of cloud storage (approximately 700 articles)
- Easy to learn
- Mobile app available
- With Mendeley you can:
  - Have online access
  - Sync and use across multiple devices
  - Easily import, organize, and annotate PDFs
  - Capture snapshots of webpages along with some citation information
  - Capture some citation information just by downloading PDFs
  - Customize journal styles
  - Generate citations and bibliographies in Word, LibreOffice, and LaTeX
  - Use social networking features to connect with other researchers in your field

## **CONS**

- Only allows sharing with one group of up to 25 collaborators unless you make your collection publicly available
- A browser add-on must be installed to download citations for webpages
- The Research Medical Library is unable to provide support for Mendeley

## **Zotero**

Zotero is an online tool that is easy to learn and allows for sharing with an unlimited number of collaborators.

## **PROS**

- Free basic version with 300 MB of cloud storage
- Easy to learn
- With Zotero, you can:
  - Have online access
  - Easily share with an unlimited number of collaborators
  - Capture snapshots of webpages along with some citation information
  - Easily tag and annotate citations
  - Choose from 20 pre-installed journal styles and [many more available](#) for download
  - Generate citations and bibliographies in Word, LibreOffice, and Google Docs

## **CONS**

- The free version offers only the most basic functions
- Offers only 300 MB of free cloud storage
- No mobile app
- The interface is slightly clunky and can slow down your computer
- Doesn't allow highlighting or annotating of PDFs
- Difficult to customize journal styles or change citation formats
- Occasionally doesn't download all citation information correctly
- The Research Medical Library is unable to provide support for Zotero

## **Building your data management plan**

Data management is the process of storing, protecting, and preserving scientific data and making it accessible. A data management plan typically outlines who will be responsible for specific aspects of data stewardship and describes how data will be collected, documented, stored, secured, and backed up. Data management plans help ensure research transparency and reproducibility, and such plans are typically required for government-funded research.

## **Funding agency requirements**

Since 2003, the US National Institutes of Health (NIH) has required investigators who apply for funding of \$500,000 or more to submit a data management plan that includes a strategy for data sharing, i.e., making research data available to the public at large or to researchers who request it, or a statement explaining why data sharing is not possible. In an effort to further expand research openness, the White House Office of Science and Technology Policy issued a [memorandum](#) in 2013 requiring data management plans for all federally funded research. Specifically, NIH and other funding agencies were directed to: “Ensure that all extramural researchers receiving Federal grants and contracts for scientific research and intramural researchers develop data management plans, as appropriate, describing how they will provide for long-term preservation of, and access to, scientific data in digital formats resulting from federally funded research, or explaining why long-term preservation and access cannot be justified.”

Grants funded by entities other than the federal government may or may not require a formal data management plan, but they typically have requirements for the management, security, and sharing of data. For example, the Cancer Prevention Research Institute of Texas (CPRIT) states in its 2019 [Policies and Procedures Guide](#), “To help advance science and improve public health, it is CPRIT’s policy that the public has access to CPRIT-funded research, as well as needs assessment information and cancer control data collected pursuant to prevention program awards.” Likewise, Stand Up to Cancer’s 2020 [Program Guidelines](#) for its SU2C Health Equity Breakthrough Team Research Grant proposals require a “clear commitment by the Team

that all data resulting from their work will be available to the scientific community at large at the earliest opportunity, as allowed under patient privacy and other applicable laws."

## Benefits and resources

Even if your funding agency does not require a formal data management plan, developing such a plan early in the planning process has several benefits. Your plan helps ensure that you keep patients' protected health information private and that you comply with the policies of the institution as well as those of the funding agency. When you are ready to publish your findings, your data management plan can help you organize and preserve data so that it is accessible for review or data sharing, which is required by many scientific journals.

## Search for funding opportunities with Pivot

Have a research project in mind, but not sure how to fund it? The Research Medical Library provides free access to [Pivot](#), the most comprehensive tool for identifying grant opportunities. Pivot indexes thousands of grants from public and private funds across a wide range of fields: from basic cancer biology and clinical trials to education and social work.

From Pivot's start page, you can get an overview of the amount of funding available in various broad research areas. To get started, select the "Funding" tab and enter your search terms. A basic keyword search can narrow the results to your specific interests. Pivot returns a list of

grants with detailed descriptions, contact information for the sponsors, grant amounts, deadlines, and eligibility requirements. With more refined searches, you can home in on grants that are directly relevant to your professional stage and your work.

Pivot allows you to filter results by sponsor type (e.g., government agency, professional society, nonprofit foundation), grant type (e.g., research, training, postdoctoral fellowship, prize or award), and investigator career stage. Pivot can even find MD Anderson internal funding opportunities if they have been added via the Research Medical Library.

One of Pivot's most useful features is the ability to set up alerts to be notified of new grants and upcoming deadlines relevant to your work. These alerts can be customized to be as broad or specific as you like. Departments and research groups can also curate lists of grants that are of interest to their members and set up periodic alerts to be sent to the whole group. For individuals, Pivot can create a researcher profile and automatically suggest funding opportunities on the basis of your previous publications.

## Expanding use of digital object identifiers in scientific publishing

The digital object identifier (DOI) system, introduced in the late 1990s, is a system by which unique and permanent digital identifiers are assigned to objects on the internet (1). A user can find an object by entering its DOI in a search engine or in the search box on the International DOI Foundation website (<https://doi.org/>).

The DOI system emerged from the world of publishing, and the first application of the DOI system was Crossref, introduced by publishers in 2000 (2). Crossref assigns DOIs to the electronic versions of journal articles available on publishers' websites. These DOIs can be styled as URLs and included in reference lists of published articles; readers can click such URLs to instantly go to a cited source.

Although you might be most familiar with the assignment of DOIs to full published articles, DOIs can also be assigned to other objects, including protocols (e.g., the ones published in [protocols.io](#)), preprints (e.g., those posted on [bioRxiv](#)), data sets (3), parts of articles (e.g., PLoS journals assign DOIs to individual figures) (4), and peer reviews. The expanding use of DOIs was the focus of a session at the 2020 Council of Science Editors annual [meeting](#).

Assigning DOIs to objects makes finding and citing these objects easier. Expect to see increasing use of DOIs in the scientific publishing ecosystem.
